## Municipal Management Association of New Hampshire (MMANH) Executive Board Minutes September 16, 2022

The MMANH Executive Board met on September 16, 2022, virtually via Go To Meeting. In attendance were President Scott Dunn, First Vice President Walter Johnson, Secretary Joe Devine, Member at Large Matt Scruton Past President Thomas Aspell and Executive Director Gail Dixon-McMahon. Members Jeanie Forester and David Salois were also present. Second Vice President Todd Selig and Treasurer Naomi Bolton were absent.

In discussion of the August 19, 2022, minutes, President Scott Dunn requested an amendment to the minutes on page one, last paragraph to change the reference from Vice President Scott Selig to Vice President Todd Selig. Walter Johnson made a motion to approve the meeting minutes of August 19, 2022, with the amendment which was seconded by Secretary Joe Devine. The motion passed unanimously.
