MINUTES. The Board approved the minutes of the E-board meeting of April 16, 2018.

TREASURER'S REPORT. Action on the treasurer's report for the period ending April 30, 2018 was deferred.

FALL MONTHLY MEETING SCHEDULE. The meeting/program schedule for the balance of 2018 was discussed with the E-board deciding to schedule meetings/programs in September and October. Rescheduling of the visit to the new Concord Community Center will likely be the topic for one meeting and the Epping Fire Chief was discussed as a topic for the other. The November conference and whether the business meeting agenda should include a broader discussion of the association's future direction as well as the joint meeting/training session with Maine (to be organized by MMANH) this year were discussed as well.

ICMA 2019 PLANNING CONFERENCE. First VP Julie Glover declined to serve as the MMANH representative to the planning conference in Nashville, Nov. 16-18, 2018. The board designated Past President Walter Johnson to fill this role on behalf of the association.
